Payment Options:

1. Payment in full (calculated by multiplying the monthly tuition rate by 12) - due by July 20, 2009.
2. Twelve equal monthly tuition payments - beginning August 5 or 20, 2009, with last payment made July 5 or 20, 2010, depending on the due date you select.

* **Extended Care** Hours are as follows:

AM - 6:30 a.m. to 8:00 a.m. (includes breakfast if here by 7:15 a.m.)

PM - 3:00 p.m. to 6:30 p.m. (includes afternoon snack)

Extended care is available at a daily rate on an as-needed basis, a.m. \$9 per day and p.m. \$17 per day.

** **Holiday Care** - Care is available for most school holidays (i.e. Columbus Day, Thanksgiving, Christmas, Spring Break, etc.). Holiday Care is available as a package or at a daily rate of \$30 per day on an as-needed basis (preregistration required). Holiday Care is available at a rate of \$45 per day on an as-needed basis if not preregistered.

Payment Options

1. You may pay the total annual tuition in full (calculated by multiplying the **Monthly Tuition** rate by ten), due by July 20, 2009, by check payable to NCS in the Preschool Office or
2. Ten equal **Monthly Tuition** payments beginning August 5 or 20, 2009, with last payment made May 5 or 20, 2010, depending on the due date you select.

General Terms

- Payments must be made through FACTS Management Company by bank draft or credit card. An annual fee of \$41 is charged for this service by FACTS, per contract.
- All tuition credit card payments will incur a Convenience Fee.
- A Change Fee of \$50 will be incurred if changes are made that reduce hours and/or days enrolled. Reduced program costs are calculated through the end of the month.
- Notification of withdrawals should be given in writing to the preschool director no later than 30 days in advance of the withdrawal date, or a \$50 Withdrawal Fee will be charged.
- Registration Fee of \$175 for Full Care and 10 Month Program is non-refundable and due upon enrollment.
